Grant Making Unit

By the end of 2017, 4 grants were disbursed under different issues supporting women empowerment. Grant of NRs 20 thousand was granted to the network of Nepal Mahila Ekta Samaj for the celebration of South Asian Women Solidarity on 30th November

Likewise, the second grant of NRs 1 lakhs was disbursed under Human Rights National Magna Meet to Sankalpa, an organization which has been demanding implementation of human rights in the country.

Third grant was the Founder's Fund grant of NRs 3 lakhs which was provided to Bhore organization from Dhanusa. The grant was provided for higher education

of 61 girls in Dhanusa district who belong to Mushahar marginalized community. Along with the scholarship program, the organization will also be conducting awareness campaigns on anti-child marriage and anti-dowry practices in Dhanusa.

Volunteer's interaction with Grantee Partner

Exposure visit to Griha Samik Barahi Sip Mulak Mahila Sahakari Sanstha Limited was organized for the newly trained volunteers. This visit was arranged mainly for the new volunteers to visit an organization where the funds they collected were given.

The purpose of the visit was to help volunteers understand community philanthropy that Tewa practices to empower women with their small support. To motivate and believe that change can happen if we work hand-inhand.

Capacity enhancement of staff on land Rights

To enhance staff knowledge and understand women's position on land rights, a talk session was organized with Jagat Deuja from Community Self-Reliance Centre (CSRC). Staff enhanced their knowledge on ferred bonded labors families kamiya, issues on land rights movement and development in Nepal.

The participants also had an opportunity to

learn about he legal provisions and gaps, importance of collective farming, community based financial institutions, holding control over local economy, challenging unjust power relations, promoting dignity campaign, among others.

Similarly, ways of community resource mapping and analysis, converting agriculture land to non-agriculture purpose, land and agrarian rights education was delivered in the session.

Tewa Center/Deepyogini



During October to December 9 local and 6 international organizations hosted their events in Tewa Centre/Deepyogini.

There were staff transitions—Gita Ghimire, Cook resigned while Samir Khadka joined as a Cook, Milan Gharti Magar as Assistant Cook and Iswor Bista joined as a Security Guard.

We have had very good production of Kiwi fruit and seasonal vegetables from our organic vegetable gardens. In these three months, Rs. 56,000 worth of vegetable and kiwi were produced which were used in Santoshi kitchen for the resident guests and to the staff. The paddy from our field produced 118 Kg of rice. And 6 kg ginger and 31 kg turmeric were harvested this year.

In house developed New Year felicitation cards were sent to 46 organizations thanking for their support and making use of Tewa Centre/Deepyogini.

We signed Memorandum of Understanding with National Society of Earthquake Technonology Nepal (NSET) as venue for their training programme

Experience shared by our Grantee Partner Jhala Kumari Dulal

A brief talk was conducted with a grantee partner Jhala Kumari Dulal, President of Mahila Sahara Samajik Sanstha, Tinpiple, Kavre (31.6 km far from Kathmandu city) who has spent over 20 years in uplifting women of Kavre, was very happy when the news of local election came to her. She had a desire to represent herself from her community so that she could challenge and change the status quo of her community women.

Tewa supported her organization for the education on the politi-



cal rights of women that were representing in different position in the election. The 2-day training was provided to 30 local women and out of them, 9 stood in the election but only 1 of them was able to win the election on the post of Deputy Mayor.

Jhala Kumari Dulal shared that the failure of women to win the elections made her very sad and she started to look into the reasons behind it. She found out that during the election, male candidates who have possession of land and property, have full right to sell their belongings and make some money to spend on promotion and campaigns for themselves.

While women, having no access to any property, had no money to spend on election promotion. Although some women had land and property under their name, they did not have any rights to sell their property without their husband's permission. Further, women candidates had nothing to offer to their supporters - not even a lunch pack or any vehicle during the promotion campaign. She said with a sad feeling "Women do not have anything to offer to their supporters not even a small drink or a snack. Because of this, most of the supporters joined the male candidates who gave them luxurious meal and drinks. This is one of the major factors affecting women and they lost the election."

She also shared her personal experience from the recent local election, which was held on September 2017 (2074), where she thought of standing herself for the position of Deputy Mayor. Her nephew was already standing for the post of Mayor and her husband had no issues with her filing her candidacy for the post of Deputy Mayor. However, for some reason, her nephew withdrew his candidacy and thereafter, she was also forced to withdrawal her candidacy.

She believes there is so much to work at the ground-level that people's mindset needs to be changed. Even now, women act on the will of their male-family members, which needs to be changed. Regardless, she is committed to continue to work on women's issues in days to come as well.
